#### VEST 2011-2012 School Year Annual Report July 11, 2012

The 2011-12 school year marked the  $23^{\rm rd}$  anniversary ( $24^{\rm th}$  year) of the VEST (Volunteers, Educators, Students, Together) Program.

This school year, the VEST program recorded **727 active volunteers**. These volunteers include Connect-Tomorrow mentors from Altec, Healthy Buddy mentors from MWSU, America Reads tutors from MWSU and A+ tutors from Benton and Lafayette.

The total number of **volunteer hours recorded was 30,686.** Of this number, 8,215 were indirect hours – those volunteers serving on a one time basis. 527 hours were from Healthy Buddy mentors, 559 were A+ volunteer hours, and 102 were from Altec mentors.

According to the Independent Sector, a national organization that tracks volunteer activity in this country, an hour of volunteer service in 2011 is worth \$21.79 per hour. This amounts to a contribution of **\$668,647** for enhanced curriculum, shared talents and expertise, mentoring and overall community support for schools.

The 3 schools with the highest number of hours were: Edison with 4,353 hours, Central having 4,128 hours, and Pickett recording 3,804 hours. Pickett had the greatest number of recorded volunteers with 155 active volunteers, Coleman totaled 92 active volunteers and Skaith recorded 85 active volunteers for this school year.

# Clarence J. Carpenter Memorial Fund Board of Trustees Annual Report 2011-2012

The Clarence J. Carpenter Memorial Fund was established by the St. Joseph Parent Teacher Association in 1937 in memory of Clarence J. Carpenter, former principal of Neely Elementary School and principal of Bliss Junior High School at the time of his death. A volunteer board of 12 members manages the fund – the St. Joseph PTA Council elects 9 and the Council President and Coordinator of Health Service also serve on the board. The Superintendent of Schools is an advisor to the Board. We currently have 2 Honorary Trustees: Mrs. Robert Beaver and Mrs. William Mooney, Jr. The Board meets in September, November, January, March, and May. Officers of 2011-2012 were Sandy Frazer - Chairman, Marcia Rippe - Vicechair, Barb Harris - Recording secretary, Heather Weddle - Corresponding secretary, and Lori Prussman - Treasurer.

This year a total of 85 students were helped with eye care. The cost of this care was \$7,709.80. This was a increase of 27 students from the previous year causing an increase of \$2,251.80 for this care. There were no dental bills presented this year.

HELP A CHILD TO SEE 2012 CAMPAIGN received \$3,182.60 in donations.

In recognition of her many years as a participating optometrist for the Carpenter Fund, Dr. Joyce Stroud was honored at the Founder's Day Dinner. The St. Joseph PTA Council made a donation to the Carpenter Fund, in her honor.

At the May meeting a budget of \$7,250.00 was approved. New officers elected for the coming year are: Sandy Frazer - Chair, Marcia Rippe - Vice-chair, Barb Harris - Recording secretary, Heather Weddle- Corresponding secretary, and Lori Prussman – Treasurer.

The Board wishes to thank all the units and individuals for the donations they have made to make it another successful year for the Board to give eye and dental care to the students of the St. Joseph School District.
