A Unit in Good Standings...

I know you have all heard this phrase, but do you really know what it means? Why do we need to be "in good standings"? What does it really effect?

Well a unit in good standings is really important. To be a unit in good standings you must have a financial review/audit done each year then send that report into State PTA and Council. You must complete the year end report; this is different from your financial review (see the forms online and you will see a slight differnce) this must be sent to State PTA and Council. You must complete the 990 N or appropriate tax form, a copy of this must be sent to State PTA and Council. You must have current bylaws and you must send in your memberships to State PTA. Finally, new officers list must be sent to State PTA and Council no later than March 31st.

Why do we need to fill out all of these forms? If you are not a unit in good standings your students are not eligible to participate in Reflections. Your unit will not be eligible for awards, grants, etc. Your unit will not be covered under the PTA umbrella. That means that if something were to happen you would not have the support of PTA.

The IRS is really trying to crack down on not for profit groups and PTA is not exempt from that. Each year the State and National PTA sign off on us assuring the IRS that we are all in compliance with their guidelines. When we don't get our information turned in we are not only hurting ourselves, but everyone else.

The Council also has a few more requirements. Council needs a copy of your budget, Council dues must be paid (\$30.00) by Oct. 15th, Council needs a copy of the St. Joseph School District form, and confirmation that your unit is covered by bonding insurance. All of these must be complete in order for your Unit to apply for our Grant program and awards.

Let's all work together to keep all of our Units in good standings. All forms must be turned in no later than Dec. 1, 2010. I suggest to send in all information as soon as you have it completed, don't wait until the last minute.
