Convention Report

As a representative of the St. Joseph PTA Council, I attended the Missouri PTA 93rd Annual State Convention at the KCI Expo Center. The convention was held October 17-19. Those in attendance had a large selection of workshops, general meetings and speakers to fill the days. There were training opportunities in areas such as membership, advocacy, leadership and marketing.

I attended classes such as PTA Votes-Millions of Members-One Voice. This class was geared towards learning how to use our voices to speak up today for our children's tomorrow. Another class I attended was No Child Left Behind (NCLB) Update. This class gave an overview of the federal law and discussed what's new and how it is working. We also discussed ideas for improving student achievement and parent involvement.

I volunteered to work at the registration booth on Saturday morning and that was fun because I got to meet other members from across the state. There are some great PTA people across the state!!!

Advocacy may be the strongest component of PTA membership. One of the PTA purposes is to secure adequate laws for the care and protection of children and youth. We should all know that our voice does matter, but collectively our voice is 83,000 strong. Another training opportunity will be coming in spring 2009 at the annual Leadership Conference. It is an important tool for training and re-energizing your PTA leaders and members. Though cellphones often seem to be a distraction, studies do show that they may strengthen the family unit. "Parents are extending themselves to provide their children with technology because they think it's important or useful," said Lee Rainie, director of the Pew Internet project. He suggests that parents and students are in touch more often, with what he calls "love taps" to touch base with each other, than what we saw 10 years ago.

Thinking on these lines we need to jump into the technology world ourselves. Obviously, cellphones, as well as the internet, make teacher-parent communication much easier. Knowing that papers often do not get to the parent in a timely manner, if at all, we can use the technologies at our fingertips to keep the parents involved. A quick email or a short call or text to their phone can let them know how they can help you.

Easy Help as Flu Season Begins

As flu season approaches there are plenty of ways our parents can help our schools. Remember, they just need to be asked.

 Host a Clean-Up Night: Invite parents and volunteers to get together to clean and disinfect classrooms.


